## Financial Assistance Scheme 經濟援助計劃

### OBJECTIVES 宗旨

- The Financial Assistance Scheme aims to provide subsidies for Coach Accreditation Programme participants who have financial hardship in gaining entry to the sports coaching industry.  
計劃旨為資助因經濟困難而未能投身運動教練行業的參加者而設，對象是參加教練級別評定計劃課程的人仕。

### ELIGIBILITY AND LEVEL OF ASSISTANCE 申請資格及援助標準

- All participants of the following courses are eligible to apply for the Financial Assistance Scheme:  
所有報讀以下課程的學員均可申請：
  - (1) Introductory Sports Coaching Course 運動教練理論入門課程
  - (2) Foundation Certificate in Sports Coaching Theory 運動教練理論基礎證書課程
  - (3) Certificate in Advanced Sports Coaching Theory 高級運動教練理論證書課程
- Course fee will be refunded in full if the applicants fulfill the following requirements:

  - a) Current beneficiary of the “Comprehensive Social Security Assistance” (CSSA) granted by the HKSAR; AND

  - b) Successfully graduated from the course

- For special cases where financial assistance is required, written requests with strong justifications should be submitted to the Hong Kong Coaching Committee for special consideration.

### APPLICATION 申請手續

- Applicants should complete the application form (FAS/2017) and send together with **certified true copies** of documentary evidence of financial hardship (e.g. Proof of CSSA, etc.) to the Coach Education Department at least one month prior to the commencement of the course. The Scheme is open for application throughout the year.
