1) Leisure and Cultural Services Department ("LCSD") provides a funding to all National Sport Associations ("NSA") to review their existing Memorandum & Articles ("M&A") because LCSD found that many NSA's M&A are not yet updated to comply with the new Company Ordinance (Cap.622) which has been effective from March of 2014. Although Federation's Special Resolution cannot be passed on two EGMs (10-Apr-2021 and 10-May-2021), the process of review the existing Memorandum & Articles ("M&A") is still going on because it is the requirement from LCSD.

Considering and, if thought fit, passing a Special Resolution to amend the Articles of Association ("AOA") as attached in Appendix-1. Which has been made previously by Squire Patton Boggs (which is a global law firm) and reviewed by the Federation's Legal Advisor, Dr. James Lee.
